Hartford Times Subscription Fund	To assist, promote, and encourage athletic sports and recreational activity for students of Alfred E. Burr School.
Batterson Park Arboretum Fund	To develop an arboretum at Batterson Park in West Hartford, Connecticut.

Charles Cooke Memorial Trust

For the beautification of the interior and/or exterior of the Municipal Building by providing a year-round exhibition of conservatory plants, seasonal floral displays and any flowering plants or shrubs that may be deemed appropriate.

Private Burial Lot Trust

To financially provide for the care and maintenance of specified private burial plots in cemeteries located in Hartford. There are approximated 128 burial plots divided among the Old North Cemetery, Ancient Burial Grounds, and Old South Cemetery.

Nile Charity Fund

To provide financial relief for those poor, heads of households, particularly widows with the acquisition of heating fuel and/or rental payments.

Thomas J. McDonough Trust

To provide a pool of prize money for students of the McDonough School who demonstrate outstanding academic or citizenship achievement and are members of the sixth grade.

Purpose

Hartford Parks Trust Fund

For the exclusive purpose of funding capital improvements and non-recurring expenses in the parks of the City of Hartford including the purchase of land for replacement purposes.

Goodwin/Old North Cemetery Fund

To financially provide for the care and maintenance (including any repair to stones and monument) of the burial lot known as the Jonathan Goodwin Lot in the Old North Cemetery.

Goodwin/North Burying Ground Fund

To financially provide for the care, maintenance and repair of the fence and/or grave marks of two double lots – Nos. 161 & 162 and 209 & 210 in the North Burying Ground in Hartford.

Henry P. Hitchcock Fund
